Assistive Devices for People with Disabilities

Sources of Funding for Assistive Devices in Ontario

The Assistive Devices Program of the Ontario Government

The Assistive Devices Program (ADP) provides funding assistance for Ontarians with long-term physical disabilities for assistive devices. It is a government program run by Ontario's Ministry of Health and Long-Term Care. It covers many different assistive devices that people with disabilities use. For more information about ADP, go to Fact Sheet 1 "The Assistive Devices Program (ADP): Ontario Government Funding for Assistive Devices".

Many assistive devices are not covered by ADP. Also, ADP usually does not cover the full cost of the assistive device. This Fact Sheet describes some additional sources of funding for assistive devices.

What Other Sources of Funding are Available?

Ontario's Ministry of Community and Social Services may provide financial aid to people who receive the **Ontario Disability Support Program** (ODSP) or **Ontario Works** (OW).

People who get ODSP or OW may receive coverage for:

- Their portion of the cost of a device funded by ADP
- The cost of assessments for assistive devices funded by ADP
- Assistive devices not covered by ADP
- Repairs and batteries for a mobility device
- Replacement of an assistive device not covered by ADP

Insurance

Some insurance programs cover the cost of buying assistive devices. As well, you may consider getting insurance for your assistive device to cover situations such as where the device is lost, stolen or damaged. To determine whether you are eligible for insurance on your assistive device, contact your insurance provider and check your insurance policy.

What Taxes Apply to My Assistive Device?

The Harmonized Sales Tax (HST) is payable on most products at the time of purchase or importation. You don't have to pay HST on some medical or assistive devices. There items include wheelchairs, walkers, hearing aids, canes, crutches and communication aids such as TTYs. Income tax relief is available for people with disabilities. This includes the Disability Supports Deduction, the Medical Expense Tax Credit and the Disability Tax Credit. The rules governing the availability of these forms of tax relief are complex, and it is important to get advice from a lawyer or accountant.
